SECTION A: Question 1 is compulsory and must be attempted

### Question 1

The Choma District Business Association recently held its Annual General Meeting (AGM) in Choma at the Golden Pillow Lodge. During the meeting, almost all the members who are Micro, Small and Medium Sized Entrepreneurs (MSMEs) complained about the harsh macroeconomic environment, which is characterized by high interest rates, high business and personal taxation, high and fluctuating exchange rate, stiff competition from cheap imported goods and many other unbearable conditions. The members particularly complained about their inability to grow or expand their businesses because of the high cost of borrowing from the traditional sources of finance, commercial banks. They equally complained to the Guest of Honour, one of the Directors at the Ministry of Small and Medium Enterprises Development, that even Government Funded institutions like the Citizens Economic Empowerment Commission (CEEC), the Development Bank of Zambia (DBZ), the Youth Empowerment Fund at the Ministry of Youth and Sport were characterized by bureaucracy, red tape and inadequate funds. They told the Guest of Honour that their businesses were likely to shut down completely. You have been invited as a ZCAS University student to prepare a paper and send it to Choma District Business Association.

### Required: -

- a) Can you discuss any Five (5) issues that citizens in Zambia complain about, regarding loans from Government Funded Institutions like the Citizens Economic Empowerment Commission (CEEC), the Development Bank of Zambia (DBZ), the Youth Empowerment Fund at the Ministry of Youth and Sport (20 Marks)
- b) Explain why most Small-Scale Entrepreneurs are not willing to finance businesses using Partnerships or Joint Venture models.
